Subject:- Revised Guidelines of Central Sector scheme "Supporting State Dairy Cooperatives and Farmer Producer organizations (SDC& FPO) engaged in dairy activities" during 2020-21

The undersigned is directed to refer to the letter dated 13.05.2020 and 21.05.2020 conveying the Revised Guidelines of Central Sector scheme "Supporting Dairy Cooperatives and Farmer Producer organizations engaged in dairy activities" for 2020-21 and to inform that as per the approval of the High Power Committee Meeting held on 29.10.20 following changes have been made on the operational guidelines of the "Interest subvention on Working Capital loan".

- The clause (d) in para 3 Eligibility Criteria for the PA in the guideline is replaced as under:
 - "(d) Interest Subvention shall be provided on back ended basis every month by National Dairy Development Board (NDDB) to Participating Agency bank account with FI after verifying the claim."
- In addition to the existing clauses, following clauses has been added for 3. processing additional 2% interest subvention in the para 6.2 Application assessment methods:
 - · The working capital loan account where all of the interest payments and/or instalments of principal were paid (through customer induced payments only) within 30 days of the due date during the tenure of the loan, would be considered as an account having prompt payment.
 - · The additional interest subvention may be processed immediately based on certificate from the Bank that the loan has been repaid / serviced promptly by the PA during the tenure of the loan or till March 31, 2021whichever is earlier.
- This issues with the approval of Joint Secretary (CDD) vide Dy.No.E-2162 dated 09.02.2021.
